**Theft by Swindle:** Yesterday deputies took at least five *theft by swindle* reports from one neighborhood. The "swindle" went like this: Residents received a phone call from 763.248.11xx. When they answered the phone a male identified himself as Lt. Brian White and referenced Hennepin County Courts, Anoka County Courts, and the Anoka County Sheriff's Office. The male stated the person receiving the call (or a family member) missed Jury Duty and a warrant was issued for their arrests. The male demanded payment to satisfy the warrant. Fortunately everyone who received the call new to just hang-up. This scam is current – make sure to share this information with people you know!
