**FRIDAY UPDATE: 07.01.16-07.08.16**

**Investigator Insight:** After reading multiple reports we noticed a trend in Blaine. There have been a number of burglaries where thieves entered through open garage doors and unlocked service doors then went into the home and stole whatever they found right inside the door – typically purses. The thieves stole credit cards from the purses and immediately started using them at various stores and gas stations.

We want to remind you to keep your garage door shut when you are not in sight of it, lock your garage service door, and lock the door between your garage and home. These are crimes of opportunity that are preventable.
