**Investigator Insight:** In the past few weeks we have seen an increase of thefts from boats, garages, and of items out of unlocked vehicles. Please remember to keep your garage door closed and the service door locked if you are not within eyesite of it. Also remove all items from vehicles and lock them - or if possible park them in a secured garage. With boats it is a little more difficult unless you have a garage to secure them in - but remove items of value, park them in an area that is difficult to get to and well lit. Most importantly - report suspicious people by calling 911 when you see them in your neighborhood!
