Below is another Craigslist scam report that we took last week.

Complainant reports on 10519 he responded to a Craigslist ad which advertised rental vacation property in Volusia County Florida. The complainant stated the male said his name was Martin and had rental property there. The complainant paid the male \$2,900.00 for the first month rental and damage deposit. The complainant was to leave tomorrow for three months. The complainant had contact with the male through the phone number of 786-373-6517 and an email address. The complainant states now both the phone number and email are disconnected. The complainant states now he is out the money. The complainant used his Visa credit card to pay the male.
