WHEREAS, the Columbus Senior Citizen Board (the “Donor”) is a 501(c)(3) corporation which was formed to provide programs and services to senior citizens within Columbus and surrounding communities; and

NOW, THEREFORE, be it resolved that the City of Columbus does hereby accept the Donation from the Columbus Senior Citizen Board and offers its sincere gratitude for the Donation on behalf of its citizens and the community.

RE: Appointment of Election Judges for the 2020 State General Election

BACKGROUND:

The City has recruited twenty (26) Columbus and/or State of Minnesota residents to serve as Election Judges for 2020 General Election. Of those judges, one (1) is scheduled to work a full shift, the remaining nineteen (25) judges will be working split shifts, from 6 a.m. to 1:30 p.m. or from 1 p.m. to approximately 9:00 p.m. Some judges may not work and will be on standby in case of an absence.

All new judges are required to participate in a two (2) hour online training course with some Election Judges participating in electronic poll book training at the City Hall. Precinct head judges and Assistant head judges will receive additional in-person training or on-line training with Anoka County. In addition, Election Judges can volunteer to participate in equipment training at the public accuracy test.

State law requires that election precincts be balanced by political party and every attempt has been made to meet this requirement.

RESOLUTION APPOINTING ELECTION JUDGES FOR THE GENERAL ELECTION TO BE HELD ON NOVEMBER 3, 2020

WHEREAS, Columbus will be conducting a General Election on November 3, 2020; and

WHEREAS, pursuant to Minnesota Statutes section 204B.21, election judges for the precinct in the City of Columbus must be appointed by the City Council; and

WHEREAS, persons selected to serve must meet all requirements of the MN statute and county administrative policy and have been trained and certified pursuant to law.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLUMBUS, MINNESOTA AS FOLLOWS:

1. The individuals listed in Exhibit A are hereby appointed to serve as election judges for the General Election on November 3, 2020.
2. In the event circumstances require judges to be appointed in addition to the persons named in this resolution, the City Clerk is authorized to appoint as necessary, provided the persons appointed meet all requirements of the MN statute and administrative policy.
