**FRIDAY UPDATE: 12.14.18**

This last we had an unsecure running vehicle stolen from a driveway, merchandise stolen from an unsecure running vehicle, and a cell phone stolen from a cart. These are all crimes of opportunity.

- ~ Do not leave your cars to warm up unattended.
- ~ It only takes seconds to open a door and grab your belongings.
- ~ Put your valuables in the trunk.
- ~ Do not leave your purse in a shopping cart – often thieves reach in, steal your wallet or cell phone and are long gone before you know your belongings were stolen.
