**FRIDAY UPDATE: 01.17.20**

We have thieves claiming to be members of our office calling residents claiming they missed a jury duty assignment. If you ever receive a call from someone claiming to be from our office, you can hang up and call us at 763.324.5000 if it is during business hours or call 911 outside of business hours. Here is the report:

On 01-14-20, at 1529 hours, I was dispatched a suspicious phone call report. The caller reported receiving a voicemail from 763-324-5000 (*this is our number, but it was spoofed for caller ID*). The caller identified himself as Paul Newsome with the Anoka County Sheriff's Office. He requested a call back at 763-645-0056. When the victim called the number, the male identifying himself as Paul Newsome, explained that she had missed her jury duty assignment with Anoka County. He advised her to go to the Anoka County Sheriff's Office and complete an affidavit explaining her absence. She ended the call before getting any further instructions. The male knew her address but did not ask for any personal or financial information. I explained the phishing scam to the victim and gave her advice for future reference.

I called 763-645-0056 and a male answered the phone as the Anoka County Sheriff's Office. I asked for Paul Newsome and was put on hold. A different male then greeted me as Paul Newsome with the Anoka County Sheriff's Office. When I identified myself, the male disconnected the call. A short time later, I called the number again to find that it was now out of service.
