FRIDAY UPDATE: 07.26.19

Prior to this week I hadn't seen any scams linked to Linkdin - below is the report.

I spoke with the RP via phone in regard to an identity theft report. The RP stated that she applied for some jobs on Linkdin and received an email stating she was hired. The company asked the RP to send them a copy of her driver's license and they would send her a check in the amount of \$4,870.00 for a computer and other supplies for the job. There were instructions telling her to cash the check and go get apple gift cards. The RP cashed the check but felt that she may be getting scammed so she called her bank back and they cancelled the deposit.

At the time of this report the RP had no monetary loss but was worried that the scammers had a copy of her driver's license. I advised the RP to monitor her finances and if any suspicious activity started showing up to call the Sheriff's Office for further investigation.
