4. PUBLIC HEARING AND DISCUSSION – WALDOCH SECOND ADDITION PRELIMINARY AND FINAL PLAT

At this time a public hearing was held to consider a request for a Preliminary and Final Plat “Waldoch Second Addition” reconfiguring two (2) existing lots. Separate public hearing minutes are prepared.

Planning and Zoning Technician Eleanor Hahn, City Administrator Elizabeth Mursko, and City Planner Dean Johnson each gave their insight to the Plat during the public hearing. No further discussion amongst the Planning Commission Members was had after closing the public hearing.

Motion Bobick to recommend approval of the preliminary plat of the Waldoch Second Addition to reconfigure Lots 4 and 5 into Lot 1 Block 1 and Lot 2 Block 1, based on finding of fact one through twelve and recommendations one through seven of the planner’s report dated November 29, 2023, and recommend approval of the final plat to reconfigure Lots 4 and 5 into Lots mentioned,

based upon the findings of fact one through five and recommendations one through eight.
