9. There are no encroachments or boundary line questions affecting the Premises of which Affiant has knowledge.
10. There is a right of access to the real property from a public right-of-way.
11. Affiant hereby represents and warrants that the Property is free of Hazardous Substances and is not subject to any "Super Fund" type liens or claims by governmental regulatory agencies or other third parties arising from the release or threatened release of Hazardous Substances in, on or about the Property.

For purposes of this Affidavit, "Hazardous Substance" means hazardous waste, toxic substances, polychlorinated biphenyls, asbestos or related materials and also includes, but is not limited to substances defined as "hazardous substances" or "toxic substances" in the Comprehensive Environmental Response Compensation and Liability Act of 1980, 42 U.S.C. Sec. 9601, et. seq. (Federal Superfund Act) as amended by the Superfund Amendments and Re-Authorization Act of 1986 (SARA), Hazardous Materials Transportation Act, 49 U.S.C. Sec. 6901, et. seq., Resource Conservation and Recovery Act, 42 U.S.C. Sec. 6991, et. seq., or as "hazardous substance", "hazardous waste" or "pollutant or contaminant" in the Environmental Response and Liability Act. MINN. STAT. Sec. 115B.01, et. seq., or the Petroleum Tank Release Cleanup Act, MINN. STAT. Sec. 115C.01, et. seq. The term does include petroleum, including crude oil or any fraction thereof, natural gas, natural gas liquids, liquified natural gas, synthetic gas usable for fuel or mixtures thereof.

12. Affiant has not received any notice from any governmental authority as to a violation of any law, ordinance or regulation. If the property is subject to restrictive covenants, Affiant has not received any notice from any person as to a breach of the covenants. Affiant has not received any notice from any governmental authority as to the existence of any dutch elm disease, oak wilt, or other disease of any trees on the property.
